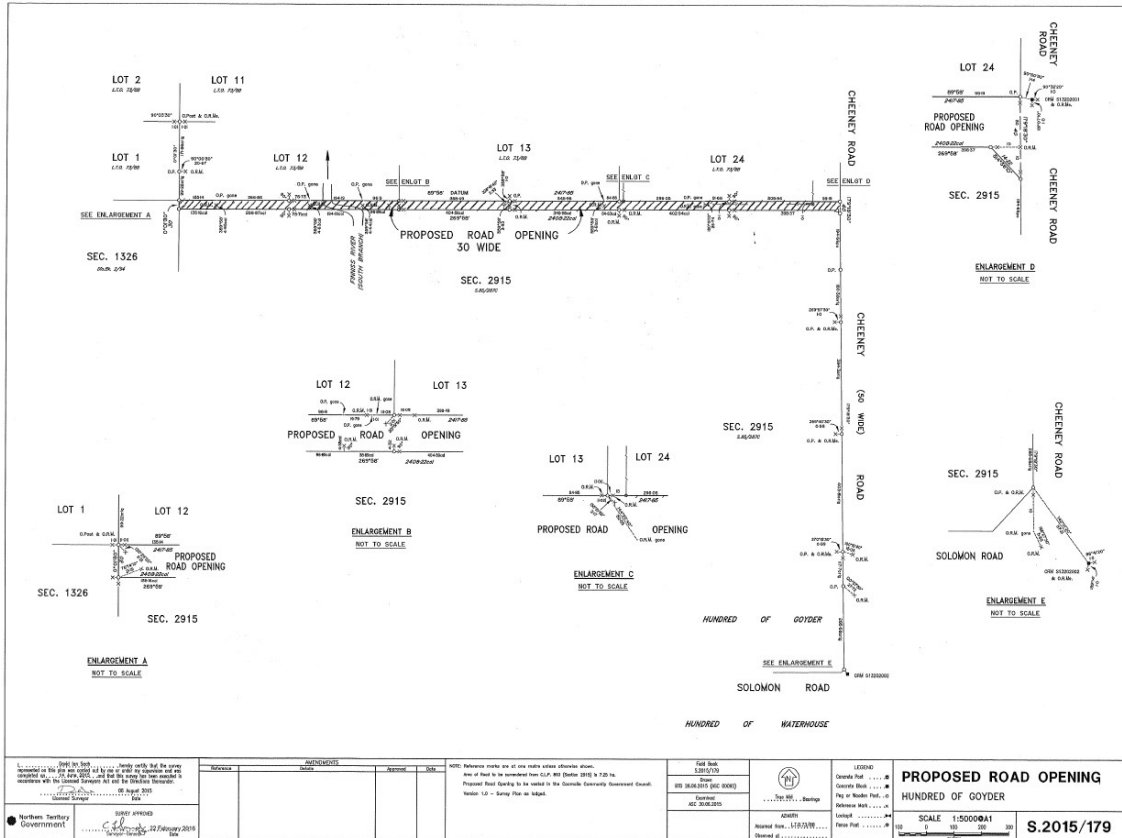
Declaration of Road

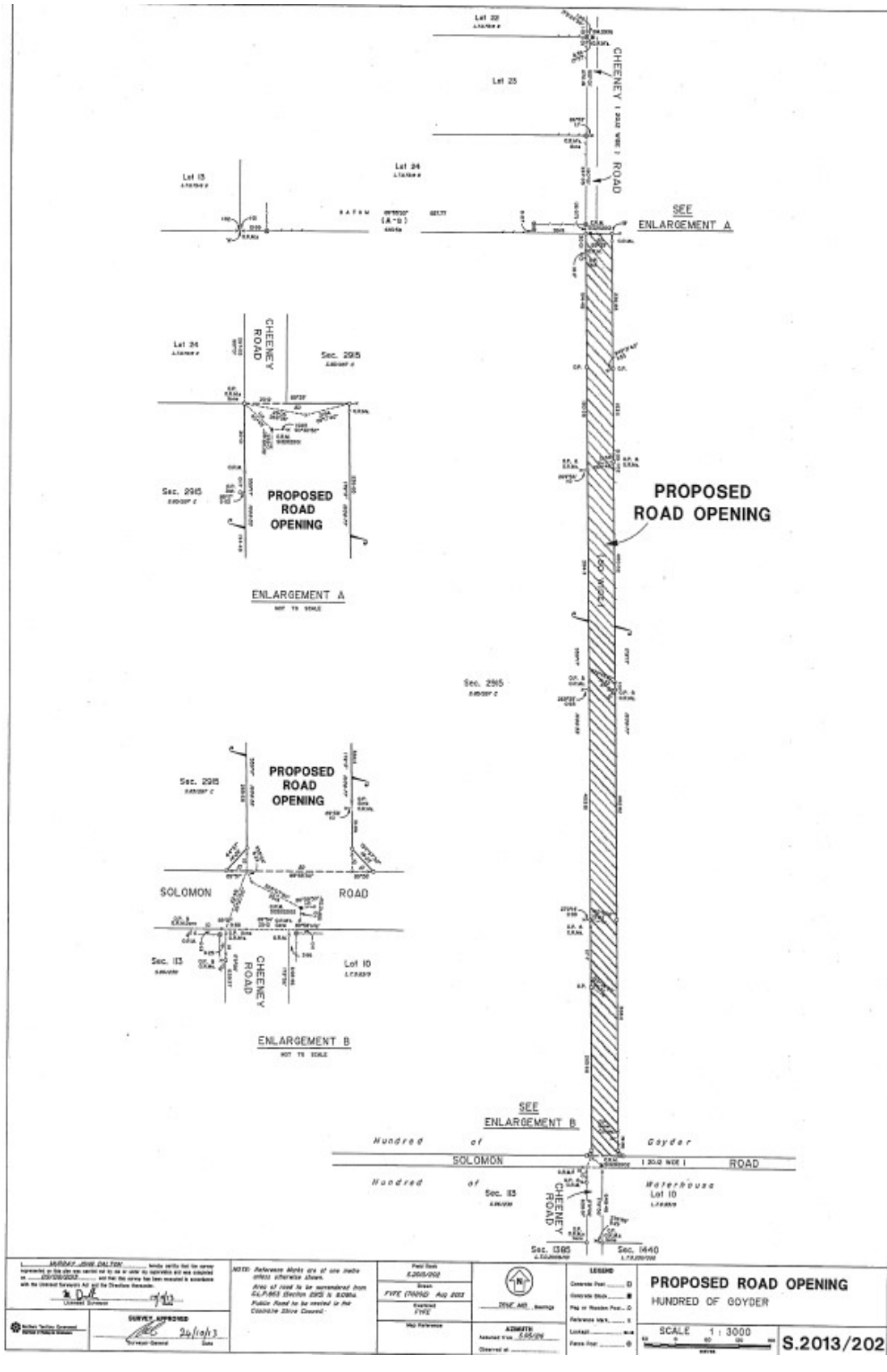
