

Apply to shoot on vacant Crown land

Application fee: \$20 including GST. Not refundable.

The applicant applies for permission to use and possess firearm on the specified areas of vacant Crown land and being sections 1663-1664, 1680-1682, 1685-1687, 1690, 1692, 1775-1780, 1826-1829, part 1830, 1832 Hundred of Ayers, part sections 4225(A) and 4226(A) Hundreds of Bagot.

In consideration of the grant of this permit, the permit holder shall release and indemnify the Northern Territory of Australia, its employees and agents from and against all claims demands proceedings costs and expenses in respect of any person or property arising out of the actions by the permit holder of any of the rights conferred by this permit.2. Permission may be withdrawn at any time by the Territory giving 14 days' notice in writing sent to the postal address shown on the application.	

3. Failure to observe the special conditions (if any) to which the permission is subject, or any other law relating to the possessing or discharging of firearms will result in the immediate withdrawal of the permission.
4. Any person exercising a right conferred by this application or permission does so on the understanding the Territory is indemnified against any claims for damages on injuries resulting from the exercising of any such right.
5. Any person exercising a right conferred by this application or permission does so on the understanding that consent to shoot on prescribed vacant crown land does not relieve the applicant of any responsibility to comply with any requirements of the *Firearms Act*.
6. Should the issued permit be lost or misplaced by the applicant, prior to the expiry of the shooters licence, then a new application must be made and a fee of \$20.00 will be payable.
