# Approval of Traffic Infringement Detection Device

LTI TruSpeed SE

- I, Jamie Chalker APM, the Commissioner of Police -
  - (a) In pursuance to section 44(1) of the *Traffic Act 1987* and with reference to section 44AA of the *Traffic Act 1987*, approve the "LTI TruSpeed SE" manufactured by Laser Technology Inc., as a traffic infringement detection device; and
  - (b) Pursuant to section 44(2) of the *Traffic Act 1987*, specify that the approval of the device under paragraph (b) is subject to the condition that it must be tested for accuracy as follows -
    - (i) the correct operation and accuracy of each LTI TruSpeed SE is to be tested no less than once in each day that the device is used for purposes of the *Traffic Act 1987* by a person operating it during that day in accordance with the testing procedures set out in the document published by the manufacturer of the device and entitled "User's Manual":
    - (ii) the accuracy of the calibration and the parameter performance of each LTI TruSpeed SE is to be tested not less than once in each 12 month period by a person approved under section 44(3) of the *Traffic Act 1987* and sealed shut at the end of the testing procedure; and
    - (iii) if the device becomes unsealed, is opened or is otherwise damaged as soon as reasonably practicable after that occurs by a person approved under section 44(3) of the *Traffic Act 1987*.
