## **Notice of Variation to the Electricity Industry Performance Code**

In accordance with section 24(7) of the *Utilities Commission Act 2000*, the Commission gives notice that it has made a variation to the Electricity Industry Performance Code (the Code), which will commence on 1 July 2023.

The Code was made in 2017 and replaced the Northern Territory Standards of Service Code and the Northern Territory Guaranteed Service Level Code. The Code has been amended to incorporate changes to guaranteed service levels and payment amounts for Power and Water Corporation's next five year network regulatory control period starting on 1 July 2024, and to address a number of issues or gaps identified by the Commission and licensees through the operation of the Code since 2017.

## **Notice of Variation to the Electricity Retail Supply Code**

In accordance with section 24(7) of the *Utilities Commission Act 2000*, the Commission gives notice that it has made a variation to the Electricity Retail Supply Code, which will commence on 1 July 2023.

The Electricity Retail Supply Code has been amended to incorporate changes to credit support arrangements, coordination agreements, service order procedures, customer transfers, retailer of last resort and life support equipment provisions. Further, the Electricity Retail Supply Code has been amended to introduce new protections for electricity customers in relation to dispute resolution, hardship and family violence.

## Release of Information under Section 61(8)

I, Unnikrishnan Karumathil, the Delegate of the Minister for Mining and Industry, in pursuance of section 61(8) of the *Petroleum Act 1984* -

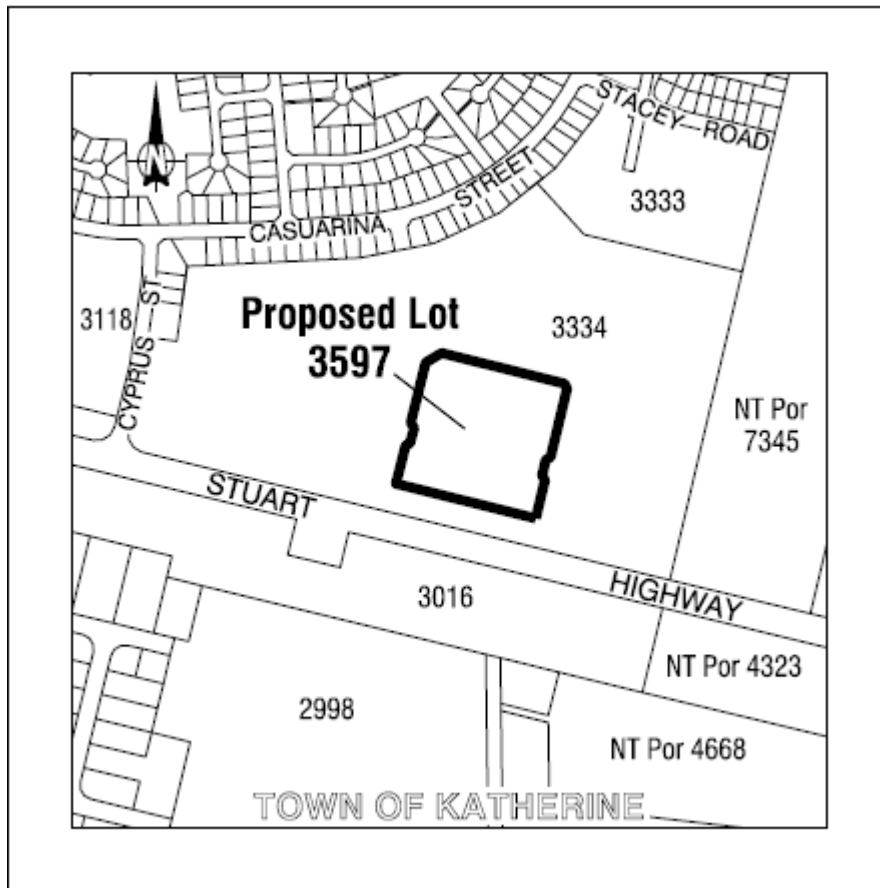
