2. Definition


In this amendment -

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

3. Amendment of zoning map

The NT Planning Scheme is amended by amending the zoning map relating to Batchelor to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered SD, PS, RR, LI and FD which is Section 2924 Hundred of Goyder (1065 Batchelor Road, Batchelor).
