

Such an objection must be made to the National Native Title Tribunal within 4 months of the notification day.

Objection or Submission, Section 71 of the Mineral Titles Act 2010: The landowner(s) of land in respect of which the following applications are made, may lodge an objection to the grant of the exploration licence application; any other persons may lodge a submission.
