Revocation of General Reservation of Land

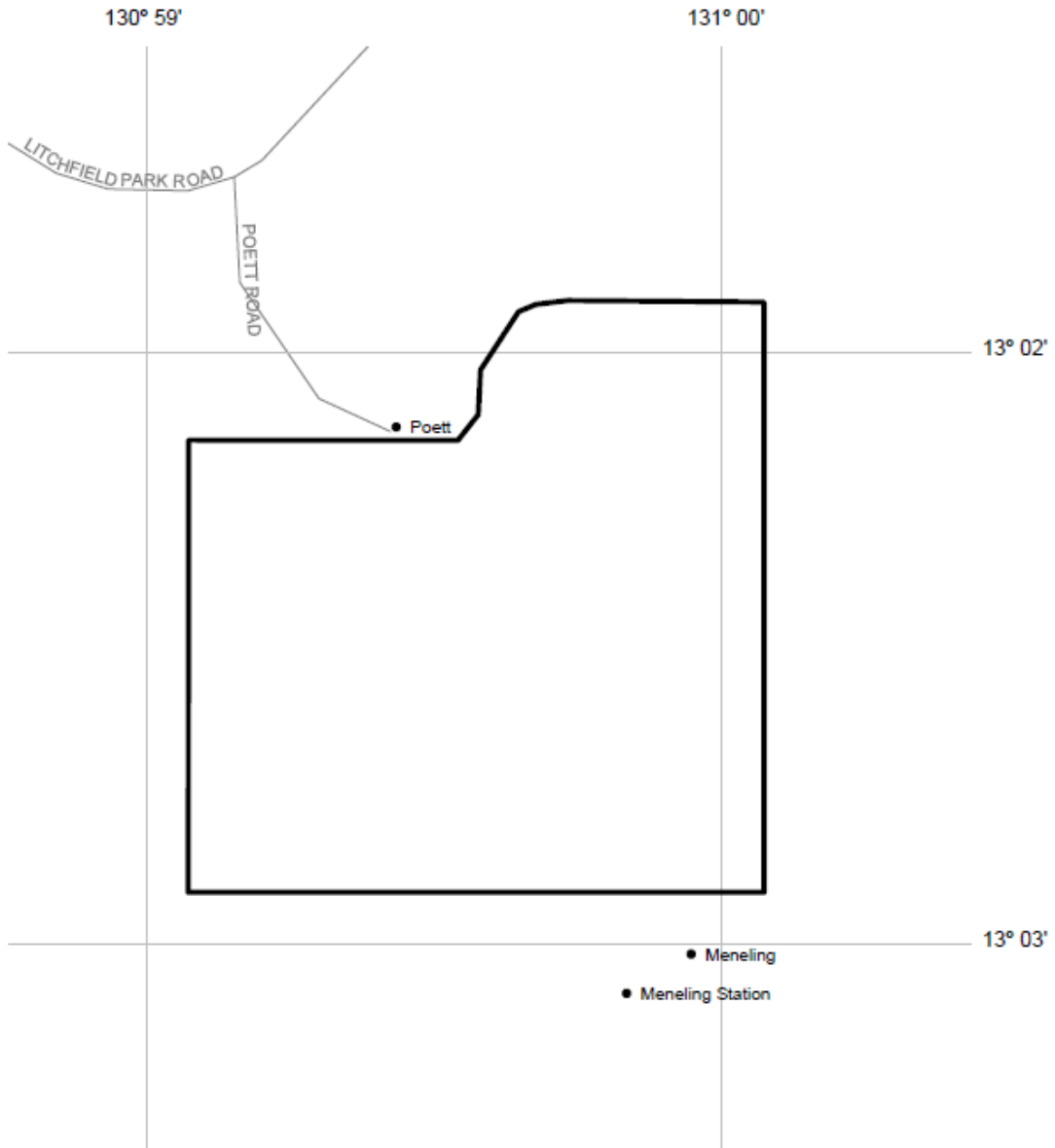
