## **Revocation, Declarations and Approvals: School Clinics**

I, Hugh Crosbie Heggie, Chief Health Officer:

- (a) under sections 250, 252 and 254(1) of the *Medicines, Poisons and Therapeutic Goods Act 2012* and with reference to section 43 of the *Interpretation Act 1978*, revoke the declarations and approvals made by the instrument entitled "Revocation, Declarations and Approval" dated 18 October 2018 and published in *Gazette* No. G43 of 24 October 2018; and
- (b) under section 252 of the Act, declare the health clinic at each school or college specified in the Schedule, Part A, to be a place to which Part 2.6 of the Act applies; and
- (c) under section 254(1)(d) of the Act, approve each Scheduled substance treatment protocol specified in the Schedule, Part B, for each health clinic mentioned in paragraph (b); and
- (d) under section 250(1)(a) of the Act, declare each nurse or midwife practising at a health clinic mentioned in paragraph (b) to be an approved

nurse or approved midwife (as appropriate) to supply, administer to another person and possess the Schedule 4 substances specified in the Schedule, Part C, in accordance with the Scheduled substance treatment protocols specified in the Schedule, Part B; and

- (e) under section 250(1)(b) of the Act, declare each Aboriginal and Torres Strait Islander health practitioner practising at a health clinic mentioned in paragraph (b) to be an approved ATSI health practitioner to supply, administer to another person and possess the Schedule 4 substances specified in the Schedule, Part C, in accordance with the Scheduled substance treatment protocols specified in the Schedule, Part B.
