Revocation, Declarations and Approval – Meningococcal Group B Vaccine

I, Charles Hawkhurst Pain, Acting Chief Health Officer:

- (a) under sections 252, 254(1) and 250(1) of the *Medicines, Poisons and Therapeutic Goods Act 2012*, and with reference to section 43 of the *Interpretation Act 1978*, revoke the declarations and approval made by the notice entitled "Revocation, Declarations and Approval – Meningococcal Group B Vaccine" dated 18 December 2020 and published in *Gazette* No. G1 of 6 January 2021; and
- (b) under section 252 of the *Medicines, Poisons and Therapeutic Goods Act 2012*, declare each health centre and clinic specified in the Schedule, Part A, to be a place to which Part 2.6 of the Act applies; and
- (c) under section 254(1)(d) of the Act, approve the Scheduled substance treatment protocol specified in the Schedule, Part B for each health centre and clinic specified in the Schedule, Part A; and
- (d) under section 250(1)(a) of the Act, declare each nurse or midwife practising at a health centre or clinic specified in the Schedule, Part A, to be an approved nurse or midwife (as appropriate) to supply, administer to another person and possess Meningococcal Group B Vaccine in accordance with the Scheduled substance treatment protocol specified in the Schedule, Part B; and
- (e) under section 250(1)(b) of the Act, declare each Aboriginal and Torres Strait Islander health practitioner practicing at a health centre or clinic specified in the Schedule, Part A, to be an approved ATSI health practitioner to supply, administer to another person and possess Meningococcal Group B Vaccine in accordance with the Scheduled substance treatment protocol specified in the Schedule, Part B.
