#### Declaration

I wish to apply to become a volunteer with NT Parks and Wildlife.

I declare for the purpose of this application I understand that:

- there is no remuneration associated with volunteer work and this application does not constitute a contract of employment.
- I must read and agree to abide by the Parks and Wildlife volunteer code of conduct before volunteering.
- I am a worker subject to the Work Health and Safety (National Uniform Legislation) Act 2011 and have a responsibility to ensure personal and workplace safety.
- there are inherent and diverse risks in the tasks that I may be asked to undertake including those that require me to travel in vehicles including off-road 4WD and all-terrain vehicles, and vessels.
- if required to drive an NTG vehicle I must obtain prior approval, read the NT Fleet Driver's Handbook and comply with the 'Driver Responsibilities' section of that handbook.
- if I am driving a non-government vehicle in connection with performing volunteer work it is my responsibility to ensure that the vehicle meets Northern Territory registration requirements and is comprehensively insured.
- I will be required to perform tasks allocated to me to the best of my ability and follow the directions and supervision of agency employee(s) appointed as my supervisor.
- I will be required to take reasonable care of the agency's property provided to me in my capacity as a volunteer or used by me in that capacity.
- while performing tasks as a volunteer I will be responsible for the security and safety of personal property (including vehicles), at all times.
- prior to starting as a volunteer, I will be required to provide details of any injury, illness or condition that may affect my ability to perform volunteer work, or which may need to be accommodated.
- the information I provide will only be available to Parks and Wildlife and that it may only be used for its intended purpose (the division's privacy statement can be obtained by contacting the agency).
- I must use government information provided to me in my capacity as a volunteer only for the purposes for which it is provided.
