Reasons for Decision

NORTHERN TERRITORY PLANNING SCHEME 2020
AMENDMENT No. 100

I have decided, under section 12(2)(a) of the *Planning Act 1999*, to amend the NT Planning Scheme 2020 to make minor administrative amendments, which have become apparent during the interpretation and application of the scheme.

I am satisfied that the amendment:

- is not significant enough to require exhibition, as the amendments are administrative in nature and will not change the intent of the planning scheme; and
- has merit and is in the public interest as it provides clarity around the identification of zone and overlay maps through other geographic means to respond to legislative changes.
