- 1. The Registrar-General or another person may lodge a standard terms document and may amend the document by lodging a further standard terms document. All or part of a standard terms document, or an amended registered standard terms document forms part of an instrument if the instrument says it forms part of the instrument and belongs to a class identified in the standard terms document as an instrument to which the standard terms document applies.
- 2. In addition to the provisions in a registered standard terms document, an instrument may include a provision incorporating other terms into the instrument. If there is a conflict between the standard terms document and the terms in an instrument, the instrument prevails.
