Application Notes

There a number of steps you must complete to apply for a new registration as an agent's representative. Please read the below notes to ensure you complete all the required steps before you submit your application.

- 1. Under section 39 of the Agents Licensing Act (http://www.austlii.edu.au/au/legis/nt/consol_act/ala164/), a person is entitled to registration as an Agents Representative if the Agents Licensing Board is satisfied that the person:
 - is aged 18 years or older.
 - is a fit and proper person.
 - holds the prescribed educational qualifications.
 - will be employed by, or in the service of, a licensed agent within the Territory.

Licensing NT will check the applicant is not a disqualified person and is fit and proper to hold a licence under the Act.

2. Before applying for a licence as an individual, you must take out an advertisement in the NT News to inform the public of your application and allow a 14 day period for people to object to the licence being granted.

For Northern Region applicants, the ad must be placed in the 'public notices' section of the NT News Saturday edition. Southern Region applicants must place the ad in the 'public notices' section of the Friday edition of the Centralian Advocate.

The licence application must be lodged with the registrar within 14 days of the notice being published.

An example of the wording of the public notice is:

Notice of intention to apply for registration as an Agent's Representative. (Full name of applicant), of (full address of applicant) intends to apply for the above licence under the Agents Licensing Act. Any objection to this application is to be made in writing to the Registrar of Land, Business and Conveyancing Agents, GPO Box 1154, Darwin, 0801 and received within 14 days of this notice.

- 3. The following supporting documents must be supplied with your application:
 - a copy of your current drivers licence or passport.
 - evidence that a Criminal History Check Application (https://nt.gov.au/industry/licences/police-and-probitychecks-for-licensing) has been lodged; a charge applies for this application.
 - evidence of educational qualifications.
 - a copy of the full page from the NT News (including the publication date) containing the advertisement of

the notice of intent.

- an employer declaration, available in the 'Employer Declaration' section above.
- a referee statement completed by an authorised person as defined in section 17 of the Agents Licensing Regulations (http://www.austlii.edu.au/au/legis/nt/consol_reg/alr273/), available in the 'Referee Statement' section above.
- a completed and signed Unattested Declaration, available in the 'Unattested Declaration' section above.
