- (a) under regulation 5 of the *Agricultural and Veterinary Chemicals (Control of Use) Regulations* and with reference to section 43 of the *Interpretation Act*, revoke the instrument entitled "Approved Training Courses" dated 4 September 2013 and published in *Gazette* No. 37 of 11 September 2013; and
- (b) under regulation 5 of the *Agricultural and Veterinary Chemicals (Control of Use) Regulations*, approve a course or combination of courses specified in the Schedule (whether provided in the Territory, another Territory or a State) as an approved training course for handling the substances specified in the Schedule opposite the approved training course.
