Outstanding rehabilitation and security requirements

- As per section 93(11) of the *Petroleum Act 1984*, you may be required to submit a replacement security. This includes a security for: o compliance with the Petroleum Act 1984 and conditions of title.
- Any outstanding rehabilitation.

- transitional arrangements under 119 of the *Petroleum Act 1984*.

A transfer fee of \$5 applies for each title.
