1. BACKGROUND.

The Applicant is a contractor who undertook the construction of a new house [redacted]. The respondent is the owner of the house.

A dispute arose between the parties regarding the payment of tax invoices #0518, #0519 and #0520 for the sum of Seventy One Thousand Five Hundred and Sixty Three Dollars Sixty Three Cents (\$71,563.63) including GST.

2. APPOINTMENT OF ADJUDICATOR.

The Applicant made an application to the Housing Industry Association (HIA) for the appointment of an adjudicator to adjudicate the dispute regarding the payment claim under the *Construction Contracts (Security of Payments) Act* on 11 October 2017. On the 12th of October 2917, I, Paul Baxter, an adjudicator registered in the northern Territory, was appointed by HIA as the adjudicator. The appointment was within the 5 working days required by the Act.

3. SUBMISSIONS FROM THE PARTIES.

11th October 2017 application filed for adjudication.

12th October 2017 Mr Rod Perkins phoned the adjudicator and followed with letter to express his client's refusal to consent to two or more payment disputes being heard simultaneously.

17th October 2017 letter from Applicant.

19th October 2017 letter from adjudicator.

 19^{th} October 2017 Respondent advised that Invoice #0518 had been paid in full

23rd October 2017 adjudicator's request for submissions

24th October 2017 Applicant submissions

24th October 2017 submission of Respondent requested

24th October 2017 Email from the adjudicator advising he was still proceeding with adjudication.

 25^{th} October 2017 Adjudication response.

4. DIMISSAL CONSIDERATIONS.

Section 33(1) of the Act compels the adjudicator to dismiss an application without making a determination on the merits, in the following circumstances:

1. Pursuant to 33(1)(a)(iii), if an arbitrator or other person or court or other body has made an order, judgement or other finding concerning the payment dispute in issue.

In this case the respondent authorised her financier, the Commonwealth Bank, to make payment of the Applicant's tax invoice #0518 IN THE SUM OF \$65,870.00 inclusive of GST. The Applicant, in her letter dated the 24th October 2017, requested the application be dismissed.

In these circumstances where the applicant has withdrawn its application and the respondent has made a payment I hereby dismiss the adjudication.
