Medicines, Poisons and Therapeutic Goods Act 2012

Revocation, Declarations and Approvals: Medimobile Pty Ltd

I, Charles Hawkhurst Pain, Acting Chief Health Officer:

- (a) under sections 250(1)(a), 252 and 254(1) of the *Medicines, Poisons and Therapeutic Goods Act 2012* (the **Act**) and with reference to section 43 of the *Interpretation Act 1978*, revoke the declarations and approvals made by instrument entitled "Medimobile Pty Ltd Declarations and Approval" dated 27 July 2017 and published in *Gazette* No. S54 of 1 August 2017; and
- (b) under section 252 of the Act, declare each health clinic specified in the Schedule, Parts A and B, to be a place to which Part 2.6 of the Act applies; and
- (c) under section 254(1)(d) of the Act, approve the Scheduled substance treatment protocol specified in the Schedule, Part C, for each health clinic mentioned in paragraph (b); and
- (d) under section 250(1)(a) of the Act and with reference to section 42 of the *Interpretation Act 1978*, declare each nurse employed by Medimobile Pty Ltd ABN 82 082 933 604 (**Medimobile**) and practising at a place

mentioned in the Schedule, Parts A or B, to be an approved nurse to supply, administer to another person and possess the Schedule 4 substance specified in the Schedule, Part D, in accordance with the Scheduled substance treatment protocol specified in the Schedule, Part C, and subject to the condition specified in the Schedule, Part E.
