

NOTICE OF PROPOSED GRANT OF MINERAL LEASES

Nature of act(s): The grant of a mineral lease under the Mineral Titles Act 2010 authorises the holder to explore and mine for minerals including (but not limited to) the processing and the removal of minerals from the lease area and the treatment of tailings or other mining material the property of the Crown on the lease area, including any extractive minerals for or in connection with any of the purposes specified in the lease document for a term the Minister thinks fit and to seek renewals.
