#### **Reasons for Decision**

Amendment No 226 represents several minor alterations that are necessary to clarify the intent of Zone SP8 (Specific Use Zone Palmerston No. 8).

Details of the changes are as follows:

- Table A to clause 4, second column should read "% of all residential lots" ie include the word "residential";
- Tables A and B to clause 6, home based business should refer to clauses 5 and 7 instead of clauses 5 and 10;
- Clause 11 Building Setbacks, sub-clause 2(b) should read "small lot integrated housing and compact housing on lots" ie insert the words "and compact housing"; and
- Clause 14 Vehicle Parking, should note the particular car parking requirements for retirement living units ie 1 space per unit as described under Clause 9 Retirement Living.
