# NORTHERN TERRITORY PLANNING SCHEME AMENDMENT AMENDMENT No. 314

Amendment No. 314 rezones Lot 2057, (10) Cowle Street, Suburb of Gillen, Town of Alice Springs to Zone MD (Multiple Dwelling Residential).

Rezoning of the site to Zone MD (Multiple Dwelling Residential) will facilitate subsequent residential dwelling development of a density that is not expected to adversely affect the established residential character or future amenity of the area. Multiple dwelling development of this site would be consistent with several other developments within the area.

The physical characteristics of the land are considered suitable to support the range of land uses and development contemplated in the Zone MD (Multiple Dwelling Residential).

#### Weeds Management Act DECLARED WEED

#### ATHEL PINE (TAMARIX APHYLLA)

I, WILLEM RUDOLF WESTRA VAN HOLTHE, Minister for Land Resource Management:

- (a) under section 7(1) of Weeds Management Act, declare athel pine (Tamarix aphylla) (athel pine) to be a declared weed; and
- (b) under section 7(1) of the *Act* and with reference to section 7(4) of the *Act*, for the purposes of preventing athel pine entering into, and managing athel pine in, the Territory, classify athel pine as follows:
  - (i) as a Class A weed for the eradication of athel pine (section 7(4)(a) of the *Act*) in that part of the Territory described in Schedule 1 (and shown for information purposes only on the map in Schedule 3); and
